# Tymber's Apple Turnovers



#### Ingredients:

- □ 4 cups water
- □ 4 sliced apples
- □ 2 tablespoons butter
- □ 1 cup brown sugar
- □ 1 teaspoon ground cinnamon
- □ 1 tablespoon cornstarch
- □ 1 tablespoon water
- □ 1 package frozen pastry sheets
- □ 2 tablespoons lemon juice



- 1. Preheat the oven to 400 degrees F (200 degrees C) then combine the lemon and 4 cups water in a large bowl.
- 3. Melt butter in a skillet. Drain water from apples, place them into the skillet and stir for 2 minutes. Add brown sugar, cinnamon, cornstarch and 1 tablespoon water, mix well until sauce has thickened.
- **4.** Cut pastry sheets into smaller squares. Spoon apples onto the center of each square. Fold over into a triangle shape, and press edges together to seal.
- 5. Bake for 25 minutes. Cool completely and add your desired toppings!
