Nicole Turner

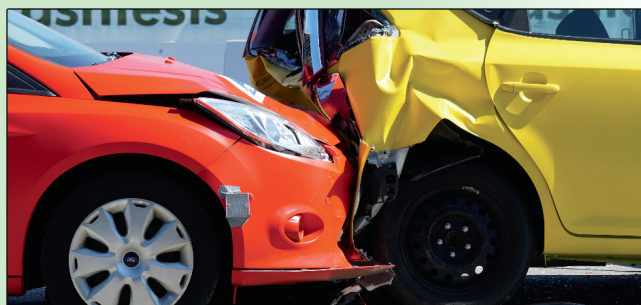

Attorney Andrew Geren, received the Rockstar award in February! Andrew runs our internship program mentoring law students to help prepare them for a career in the legal field.

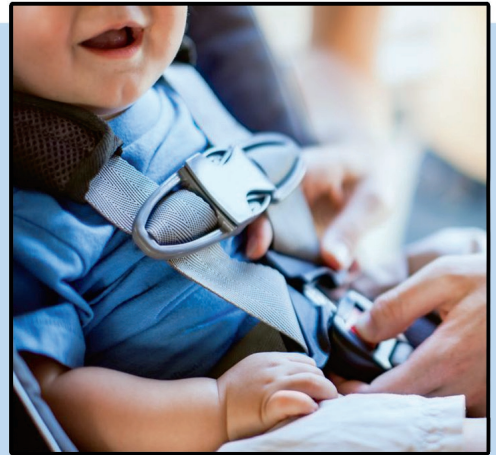

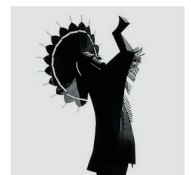
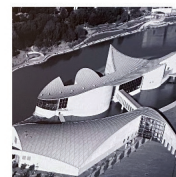
